Introduction

The City of San Luis Obispo Bench Mark System was established to provide a consistent datum plane for architects, engineers and builders to ensure proper design and construction of improvements. All construction, surveys, plans and projects within the City of San Luis Obispo would be related using this common datum plane.

This booklet provides a listing of bench marks found within and surrounding the City of San Luis Obispo. These benchmarks are on the NAVD 1988 datum. The listed elevations are in feet rounded to the nearest 0.01 foot. The City's bench marks, in most cases, are lead & tacks set in curbs near the BCR approximately 2 mm above the concrete surface. Many USC&GS published benchmarks falling within the City limits have also been included in the City's Bench Mark System.

The description for each bench mark includes, first, the name of the street where the bench mark is located and second, the cross street. Example: L&T near the BCR at the SEC of Patricia and Daly = A lead and tack near the beginning of the corner radius on Patricia at the southeast corner of Patricia and Daly. Benchmarks that have been reset or relocated have been noted with the addition of a letter next to the point number.

Maps are included to help the surveyor identify the nearest benchmark to their work location.

Disturbed or Destroyed Bench Marks

Bench marks disturbed or destroyed during construction shall be reset by responsible party in accordance with current City Standard Specifications Section 5-1.36E, "Survey Monuments".

Federal Emergency Management Agency (FEMA) Flood Plain Maps

FEMA Flood Insurance Rate Maps (FIRM) may be found at https://msc.fema.gov/portal. FIRMs are created by the Federal Emergency Management Agency (FEMA), but the citing of a bench mark on a FIRM does not necessarily imply the bench mark was used in related flood studies or the creation of the map. Additional information about the control used to create a FIRM may be available in the Flood Insurance Study (FIS), a detailed compilation and presentation of flood risk and elevation data for specific watercourses, lakes, and coastal flood hazard areas within a community. Specific questions about a FIRM should be directed to FEMA.

Background

1979-80 - Original Survey

The benchmark system was originally surveyed from a starting point at Bench Mark No.1, a United States Coastal & Geodetic Survey [USC&GS] (now Nation Geodetic Survey or NGS) brass cap #1-25 on top of a masonry wall at the NW side under the Railroad overpass at Monterey and Pepper Streets. Approximately 350 bench marks were established throughout the City in 1979 & 1980. Most of the prior City bench marks (referred to as "Old City bench marks") were incorporated into the new benchmark network with new numbers assigned. This original work showed that the "old" sea level datum of the City was +0.17 feet higher than the sea level datum of 1929 as was established by the USC&GS. This was confirmed by USC&GS's new and old bench mark listings. All of the bench marks established in the original survey were surveyed in English units. (See City Council Resolution #1402, January 3, 1955).

All City work was within second order leveling accuracy: (0.035)(miles run)^{1/2} using a Zeiss automatic level and Philadelphia rod reading to hundredths of a foot and estimating to thousandths of a foot. Errors of closure were adjusted by prorating the error in hundredths and thousandths of a foot over the total length of the level line in miles and decimals thereof.

USC&GS bench marks included in the level lines all tied together within 0.02 hundredths of a foot, except Bench Mark No. 8, a USC&GS brass cap #T-25 at Copeland's Store, which had been reset. It tied to 0.04 hundredths of a foot.

1982-83 - Added Supplementary Bench Marks (3rd Order)

Supplementary bench marks were set and the level lines run during the winter of 1982-83 to third order accuracy. These supplementary numbers run from S-1 to S-39.

1987 and 1989 - Additional Benchmarks Added.

Additional benchmarks were set and the level lines run during 1987and again in 1989. Several in fill level lines were also added. The numbers of these new benchmarks are from 348 to 403

<u>1991 – Revision of Bench Marks Due to Settlement.</u>

The area around Hwy 101 in the south part of the City has undergone settlement. This settlement was first noticed in the summer of 1990. The benchmarks in the settlement area were monitored two to five times between August of 1990 and May of 1991. It was found that they had stabilized around March of 1991. The benchmarks in this area were revised and published in May of 1991. "Rev 5/91" denotes these revised benchmarks in its description.

1996 - Metric Conversion

In 1996 the City began a conversion to the metric system of measurement. All the benchmarks listed in this book were originally established using the Imperial System. The elevations were converted to the metric system using a conversion factor of 0.3048 times the feet measurement to arrive at a meter elevation. **These numbers were then rounded to the nearest 5 mm.** Example. 373.35'=113.797 m shown as 113.800 m.

2000 - Adjustment to North American Vertical Datum of 1988 (NAVD 88)

The National Geodetic Survey is no longer maintaining 1929 Datum elevations for their bench marks. When a bench mark is disturbed it is replaced and a new elevation is determined based on the newer 1988 datum. For this reason, the City has chosen to move its Bench Mark System to the 1988 Datum. Considering the great number of bench marks currently listed, the decision was made to <u>not</u> resurvey the system at that time. Instead the City bench mark elevations have been "adjusted" to the NAVD 88 by adding the calculated elevation difference between the 1929 City datum and the NAVD 88 datum.

This calculated elevation difference was determined by using the 13 USC&GS bench marks found in the City Bench Mark System (Pt #'s 1, 2, 7, 8, 15, 42A, 47, 72, 74, 134, 156, 333 and 390) and determining the average elevation difference between the City's 1929 elevation and the currently published 1988 NGS Datum elevation. The average elevation difference of 749mm was added to the City's metric 1929 datum elevations (before rounding). These adjusted elevations were then rounded to the nearest 5mm.

2004 - General Verification and Update of Bench Mark System book.

All bench mark sites were visited to verify their existence. Any Benchmarks that were not found or were known to have been destroyed were removed from listing and placed in Appendix A for reference. The City may reset some or all the destroyed bench marks in which case they will be added back into the system.

<u>2007 – Imperial System Conversion.</u>

In 2007 the City converted from the metric system to the imperial system of measurement. To eliminate any conversion error, the City used the 1991 published benchmark values based on the NAVD 29 Datum. These values were then adjusted to the NAVD 88 Datum by adding 2.457 feet (see 2000 Benchmark notes for adjustment information). These adjusted elevations were then rounded to the nearest 0.01 foot.

2017 - General Update of Bench Mark System book.

In 2014, the City performed a high precision Vertical Control Network Verification Survey (2014 VS) where 95 benchmarks were resurveyed using CALTRANS second order leveling standards. As in the original 1979-1980 survey for this Bench Mark System, bench mark 1 (NGS-PID FV0340) a USC&GS brass cap on top of a masonry wall at the NW side under the rail road overpass at Monterey and Pepper was held fixed. 50 level runs were performed between May 19th 2014 and August 14th 2014. A total of 1574

measurements were made and 28.68 miles were covered during the leveling campaign. A Topcon DL-102C digital barcode reading level was used for all level runs. The instrument was collimated every day prior to performing level runs. Each measurement was comprised of three separate readings; these measurements were made and recorded to 0.001', but were rounded to the nearest hundredth of a foot for this benchmark book. All level runs exceeded the CALTRANS second order specification for maximum misclosure [0.04 feet x (\sqrt{E})] where E = Length of loop in miles (loop is defined as a series of setups closing on the starting point).

The individual level runs were adjusted by prorating the misclosure as a function of the number of measurements per level run. Nearly all of the bench marks were leveled through twice and the two resulting elevations values were averaged for the published value.

The 95 benchmarks that were resurveyed in 2014 have been noted with a footnote in the benchmark description table. Benchmarks that were found to be missing or destroyed have been indicated in the benchmark descriptions and listed in detail in Appendix A: Record of Missing Benchmarks.

May 2019 - General Update of Bench Mark System book.

May 2017 Survey

In May 2017, a vertical control survey was undertaken to update the elevations for a portion of the City's Bench Mark System.

As in the original 1979-1980 survey for this Bench Mark System, Bench Mark 1 (NGS-PID FV0340) a USC&GS brass cap on top of a masonry wall at the NW side under the rail road overpass at Monterey and Pepper was held fixed.

Caltrans Second Order Differential Leveling Standards were adhered to for all level runs performed during the survey. The individual digital level loop runs were performed between May 26, 2017 and August 4, 2017 with a Leica DNA03 barcode digital level. The digital level records three separate readings, which are averaged to determine the precise elevation differences between each benchmark. Each level loop was initiated from a closed back onto either a "fixed" benchmark or a previously established benchmark whose elevation was determined as part of a prior closed loop leveling run. A total of 32 individual closed precise leveling loops were performed that covered close to 29 miles in total length.

The 127 benchmarks that were resurveyed in 2017 have been noted with a footnote in the benchmark description table. Benchmarks that were found to be missing or destroyed have been indicated in the benchmark descriptions and listed in detail in Appendix A: Record of Missing Benchmarks.

October 2018 & March 2019 Surveys

In October 2018, the City commissioned an additional benchmark network survey to complete the network survey update for all City benchmarks.

As in the original 1979-1980 survey for this Bench Mark System, Bench Mark 1 (NGS-PID FV0340) a USC&GS brass cap on top of a masonry wall at the NW side under the rail road overpass at Monterey and Pepper was held fixed. The datum used was the North American Vertical Datum of 1988 (NAVD88).

Caltrans Second Order Differential Leveling Standards were adhered to for all level runs performed as part of this survey. Individual level loop runs were performed between October 22, 2018 and December 20, 2018 using a Trimble DiNi (0.7mm per km accuracy) Digital Bar Code Reading Level for all level runs. Additional survey was completed in March 2019 to update benchmarks that had been missed in prior surveys.

All benchmarks recovered as part of the survey were leveled through via closed loop elevation traverses. Each level loop was initiated from and closed back onto either a "fixed" benchmark or a previously established benchmark whose elevation was determined as part of a prior closed loop leveling run. A total of 83 individual, closed, and precise leveling loops were performed that covered approximately 44.6 miles in total length.

The 161 benchmarks that were resurveyed have been noted with a footnote in the benchmark description table. Benchmarks that were found to be missing or destroyed have been indicated in the benchmark descriptions and listed in detail in Appendix A: Record of Missing Benchmarks.

As of May 2019 document, all existing benchmarks in this document have been resurveyed since 2014.

July 2020 - Replacement of Missing or Destroyed Benchmarks.

With all benchmarks resurveyed as of the May 2019 update, a new effort began to replace missing or destroyed benchmarks identified by the prior surveys. This work set and established elevations on 18 newly constructed and measured benchmarks throughout the downtown area. Aluminum discs with elevated domes at the center were set for all new benchmarks.

The elevation of each benchmark was determined by differential leveling from existing City benchmarks. As with prior surveys, field procedures adhered to Caltrans Second Order Differential Leveling Standards, with leveling loops occurring between February 25 through May 12, 2020. Measurements were collected and recorded with a Trimble DiNi 0.7mm Digital Level and 2 bar-code leveling rods. The vertical leveling network consisted of approximately 3.5 miles of closed loops, with the network being comprised of 1 primary loop totaling 2.3 miles with 5 secondary loops totaling 1.2 miles.

October 2024 - Replacement of Missing or Destroyed Benchmarks.

With all benchmarks resurveyed as of the May 2019 update, a new effort began to replace missing or destroyed benchmarks identified by the prior surveys. This work set and established elevations on 21 newly constructed and measured benchmarks throughout the downtown area. Aluminum discs with elevated domes at the center were set for all new benchmarks.

The elevation of each benchmark was determined by differential leveling from existing City benchmarks. As with prior surveys, field procedures adhered to Caltrans Second Order Differential Leveling Standards, with leveling loops occurring between October 9 and October 23, 2023. Measurements were collected and recorded with a Trimble DiNi 0.7mm Digital Level and 2 bar-code leveling rods. There were two leveling networks consisting of 3 loops in the northern network and 6 loops in the southern network. All level loops start and end on the same point.
