

We are committed to keeping you informed. The following is an update on the City's response to slow the spread of the novel coronavirus (COVID-19) and reduce the impact on our community.

#### Plans Underway for a Phased Reopening

The City and County are in the process of developing a plan for a phased reopening, but that effort is focused on how it will happen and not when. That decision will be made by the County Public Health Officer based on scientific guidance and data, in coordination with public and private partners, to ensure the community reopens and the local workforce gets back to work as safely as possible. In addition, the County cannot reopen until such time as the Governor modifies the Statewide order and returns full or partial authority to local agencies.

Ultimately, we will all need to adapt to a new normal as the community and commerce opens gradually in planned phases as determined by data and public health officials. Remember, it's a dimmer, not a light switch.

## County Relaxes Some Business Restrictions

The County has clarified that some business sectors can safely operate under the Shelter at Home order:

• Construction, recreational fishing, elective surgeries, and pet groomers. Click here to read more.

- Planning, Engineering, and Building functions are ready to serve you, and we are accepting new applications of all types.

- We have implemented new protocols for site inspections to ensure the safety of our customers and our employees. Community Development maintains social distancing in all its functions.
- The Community Development Department public counter remains closed, but we have been successful in supporting our customers' success remotely and will continue to do so until it is safe and recommended that public facilities reopen.
