Disclaimer: City of San Luis Obispo PublicWireless Network Acceptable Use Policy

In order to provide the users with free Internet access, the City of San Luis Obispo has adopted an Acceptable Use Policy (AUP) for the PublicWireless network. Please read this policy prior to accessing the PublicWireless network. The word "user" is used to refer to any person, entity or business that accesses the PublicWireless network. By using the service the user agrees to the terms of this AUP.

Applies to:

Users of the PublicWireless network in and around San Luis Obispo, California.

Summary:

The City of San Luis Obispo through PublicWireless provides a public wireless network for the purpose of enabling users to access the Internet. Use of the PublicWireless network is governed by all applicable local, state, and federal laws, and this wireless network AUP. The City of San Luis Obispo offers the PublicWireless network as a free service and does not provide technical support for users. For instructions on how to connect to the network, please refer to the document "How to connect to the PublicWireless network."

Authority:

The City of San Luis Obispo reserves the right to cooperate with legal authorities and/or injured third parties in the investigation of any suspected crime or civil wrong in compliance with applicable laws and regulations. Such cooperation may include, but shall not be limited to, providing account or user information or email as well as the monitoring of the PublicWireless network in compliance with applicable law. The City of San Luis Obispo through PublicWireless does not guarantee any level of quality of service and may restrict access to the network, limit the bandwidth available to any user or group of users and restrict usage time at any time.

Privileges of Network Users:

The purpose of the PublicWireless network is to provide a convenient wireless means of Internet access for the interest, information and enlightenment of the community the City serves. PublicWireless users will be granted non-exclusive limited access to this wireless network in the designated areas as technology and network capacities allow and as restricted by this AUP and subject to the constraints such access places on the City. Users may not resell the service or provide the service to third parties in exchange for any form of compensation. Official City business will at all times have priority of access to the network.

Responsibilities of Network Users:

- 1. Access to the wireless network is through individual accounts with password protection. All willful violations of this policy that are traced to an individual account name will be treated as the sole responsibility of the owner of that account. Users will be responsible for all activities occurring under the user's username and password, and for keeping the user's password secure. Do NOT share your username and password with others.
- 2. Users are responsible for ensuring they have the appropriate compliant wireless card (802.11bgn), securing their devices and if available, must run up-to-date antivirus software on their wireless device.
- 3. Please know that wireless technology is a shared resource among all City wireless devices, therefore, speeds will be directly affected by the number of simultaneous users.
- 4. Users will not use PublicWireless to violate any applicable federal, state, local or international laws, or City policies, for example, but not limited to:
 - User will not transmit any material that threatens or encourages bodily harm or destruction of property or which harasses, abuses, defames or invades the privacy of any other person or entity.
 - User will not use the PublicWireless network to commit any crime, act of terrorism, or fraud, or to plan, encourage or help others to commit any crime or fraud, including, but not limited to, acts of terrorism, engaging in a pyramid or ponzi scheme, or sending chain letters.
 - User will not use the PublicWireless network to send or receive any information which infringes the patents, trademarks, copyrights, trade secrets or proprietary rights of any other user.
 - User must respect all copyrights. Licensed commercial software may only be installed on devices expressly covered by the licenses. The downloading or sharing of copyrighted materials in violation of law is strictly prohibited.
 - Any action which promotes or furthers an illegal usage is prohibited and will be blocked by filtering software.
- 5. Users will not use PublicWireless to violate any applicable City policies, for example, but not limited to:

- User will comply with City of San Luis Obispo's Anti-Discrimination and Unlawful Harassment Policy.
- User will not access sites restricted for City use or engage in any action which promotes or furthers prohibited uses, including use of the PublicWireless network to access or transmit pornographic, sexually explicit or otherwise obscene material, content which will be blocked by filtering software.
- 6. User will not disrupt the PublicWireless network, for example, but not limited to:
 - User will not access the accounts of others or attempt to penetrate the security measures of the PublicWireless or other City network or other computer systems ("hacking") or to cause a disruption of the PublicWireless or other City network's availability to other online users.
 - User will not use tools designed for compromising network security, such as password-guessing programs, cracking tools, packet sniffers or network probing tools.
 - User will not willingly introduce malware (such as Trojans and spyware).
 - Users will not connect to "Peer to Peer" file sharing networks or download large files, such as CD ISO images, without prior City authorization.
 - Users will not run programs, services, systems, processes or servers by a single user, or group of users, that may substantially degrade network performance or accessibility.
 - Users will not distribute bulk electronic chain letters, bulk email, or other forms of solicitation ("spamming"), or mail bombs, the distribution of which requires excessive network capacity.
- 7. The City of San Luis Obispo reserves the right to immediately block access to sites that fall within the above expressly prohibited categories. Computers that attempt to access sites categorized as security risks 5 or more times in 24 hours will have their Internet access suspended until City staff can assess the security risk.

Violations and Sanctions:

Reporting Violations: Any knowledge or evidence of violations of this AUP should be reported to webmaster@slocity.org.

Penalties: Users who violate this AUP may be subject to the range of sanctions including, but not limited to, termination of network privileges and legal action. The

City of San Luis Obispo through PublicWireless has the authority to temporarily revoke network access or take other appropriate action in order to maintain network security and reliability.

Revisions/Termination: The City of San Luis Obispo reserves the right to revise or terminate the PublicWireless network and this AUP at any time, for any reason, and without notice, including the right to terminate with or without notice, without liability to any user, the network privileges of any user or any third party. Usage of the PublicWireless network indicates that you understand and agree to the terms and conditions listed herein and to any revisions.
