# Purpose

The intent of the Retrofit Upon Sale Program is to encourage the use of water efficient plumbing fixtures.

**Requirements –** Apply to all properties in the City of San Luis Obispo.

- 1. Prior to sale, bathrooms must be completely retrofitted with a 1.6 (or less) gallon per flush toilet(s).
- 2. Installation of retrofitted appliances must be in accordance with Uniform Plumbing Code.
- 3. Inspection by a licensed contractor *or* a Water Resources staff member is required for verification prior to sale (see "Inspection of Retrofitted Items" below).

The City recommends that the sewer line be cleaned at the time of installation if it has not been cleaned within the previous twelve months.

# **Inspection of Retrofitted Items**

Properties will be inspected after the installation to ensure compliance with Uniform Plumbing Code. If the retrofitting was done by a licensed plumbing contractor and his/her signature appears on the front of this form, an inspection is not necessary. Please call the Utilities Office at 781-7215 to schedule an inspection appointment. Office hours are 8:00 A.M. to 5:00 P.M., Monday through Thursday and every other Friday.

# Water Conservation Certification

Effective October 15, 1992 the San Luis Obispo City Council passed into law the Retrofit Upon Sale Ordinance #1224. This Ordinance requires that, prior to transfer of ownership, dwellings must retrofit with water conserving plumbing fixtures. It is customary for the property seller's real estate agency to verify compliance with the City's water conservation law.
