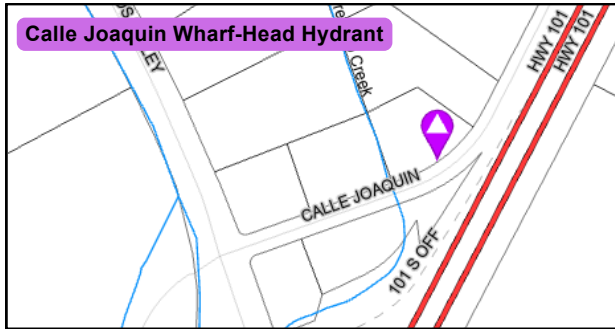

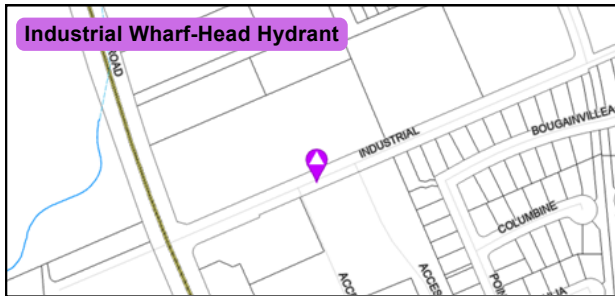

Calle Joaquin Wharf-Head Hydrant



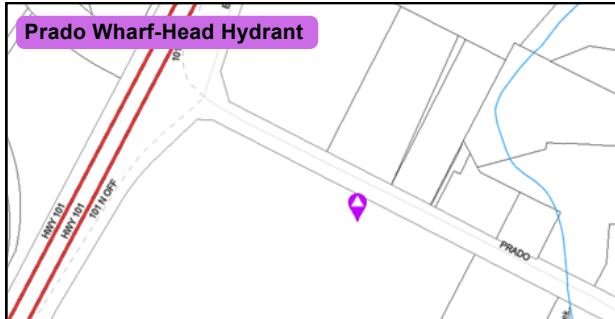

Industrial Wharf-Head Hydrant



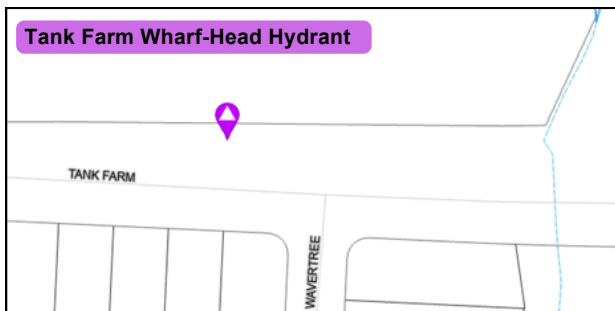

RECYCLED WATER USE

The City of San Luis Obispo produces tertiary treated recycled water in compliance with the State of California. Recycled water is approved for use within the City for construction purposes such as dust control, compaction, and grading as well as for irrigation purposes in HOAs, commercial complexes, and new developments.

PERMIT REQUIREMENTS

Construction water permit holders are required to submit a permit application, provide documentation of each water hauling vehicle and advise all drivers of the proper use of recycled water and the recycled water wharf-head hydrants.

Each water hauling vehicle must show proof of the following:

- Vehicle must have an approved air gap or backflow device
- Vehicle must display non-potable signage or “DO NOT DRINK”
- Vehicle must have a hydrant wrench on hand
- Each vehicle listed on the permit must carry current permit copy on hand
- Each vehicle listed on the permit must display City issued vehicle tags for the current permit term

PERMIT APPLICATION & FEES

Construction Water Permit applications are available at slocity.org/water and can be submitted via email at UT_services@slocity.org or in person.

As of October 1, 2024, permit fees have changed according to the following schedule:

	Annual (12 month)	Semi- Annual (6 month)	Quarterly (3 month)
Permit Fee +1 Vehicle	\$2,013.60	\$1,158.28	\$712.08
Each Additional Vehicle	\$1,490.10	\$745.05	\$372.00

Permits are not prorated and cannot be extended. If applicable project falls between permit durations, upgraded permit is required.

ENFORCEMENT

Construction Water Permit holders are to access [purple wharf-head style hydrants](#) only.

City staff monitor use of the wharf-head hydrants to verify compliance with permit procedures. A Construction Water Permit may be withdrawn if it is known that the permit holder is using the recycled water in a manner inconsistent with permit procedures and the City’s Recycled Water Use policy.

FAQ

Question: What is the process for obtaining a Construction Water Permit?

Answer: Interested parties should submit a completed application to UT_Services@slocity.org. Utilities staff will review application, advise if vehicle inspections are required, and instruct applicant to submit permit fee to the Finance Department. Once fees are paid and inspections approved, the Permittee will be issued a permit and vehicle tag.

Question: What period does the Construction Water Permit cover?

Answer: Annual Construction Water Permits are issued beginning on July 1 and are valid through June 30. Semi- Annual Construction Water Permits are issued for July-December or January-June. Quarterly permits are issued on a 3-month basis.

Question: What is the outlet size on the wharf-head hydrants?

Answer: The wharf-head hydrants have a 2 ½” outlet.

Question: Who should be contacted if there is a problem with a wharf-head hydrant?

Answer: If you encounter problems with any of the wharf- head hydrants, please contact the City of San Luis Obispo Utilities Department at 781-7215.

Question: What forms of payment are accepted for the annual Construction Water Permit?

Answer: The City’s Finance Department accepts cash, check, Visa or Mastercard.
